Registration of Vacant Property

Instructions

- 1. All vacant or foreclosing properties must register with the Borough of Wharton in accordance with Ordinance # 0-15-17 of the Borough Code.
- 2. Please complete form for vacant property and submit with registration or renewal fee in accordance with Ordinance O-15-17 of the Borough Code.

Fee Schedule

- 1. The initial registration fee for vacant residential property shall be five hundred dollars (\$500.00). Fee must accompany the registration form and shall be valid for the remainder of the calendar year in which the property is registered.
- 2. Renewal registrations for following years will run from January 1 to December 31.
- 3.All fees will be due by January 15^{th} of the relevant year. First annual renewal shall be (\$1,000.00), Second Annual renewal shall be (\$3,000.00), the third and subsequent renewals are set at (\$5,000.00).
- 4. Registration fees and renewal fees will not be prorated or refunded.
