Resolution Authorizing the Award of Discretionary and Open Contracts for the Borough of Wharton

WHEREAS, the Borough of Wharton has a need for professional auditing services, engineering services, grant writing services, legal services, and planning consultants as discretionary and open contracts pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Chief Financial Officer has determined and certified in writing that the value of the professional services may exceed \$17,500; and

WHEREAS, the anticipated term of each contract is one year; and

WHEREAS, the certification by the Chief Financial Officer that funds are available is contingent upon the adoption of the 2016 temporary budget and the 2016 municipal budget.
