**DESCRIPTION:** The work consists of the installation of approximately 225 linear feet of 10" replacement water main, wet taps, valves, and fire hydrants, along East Dewey Avenue (County Route 642). Contractor shall obtain Morris County Road Opening Permit.

**BID SUBMISSION PROCEDURES:** Bids must be submitted on the Bid Forms contained in the Contract Documents and must be enclosed in a sealed envelope plainly marked on the outside with the name of the project and the name and address of the bidder. The bid must be delivered to the owner prior to bid opening at the above address. Bids will not be accepted after **April 16, 2020 at 10:30 A.M.** 

Please note that all bids must be dropped off to the Borough Municipal Building at the drop box located at the West Central Avenue entrance to the building. Please place all bids in the box no later than 10:30 am. The Clerk will retrieve all bids at 10:30 am and close the bid.

**PUBLIC BID OPENING AND READING:** Bids will be opened and read aloud, live via an online link after the bid is closed on **April 16, 2020 at 10:30 A.M**. The online link will be provided to Plan Holders in advance of the opening.

**BID SECURITY:** Bid Security is required in an amount of not less than ten percent (10%) of the total amount of the Bid, but not in excess of Twenty-thousand Dollars (\$20,000.00) as set forth in N.J.S.A. 40A:11-21.

**CONSENT OF SURETY:** Certificate from a Surety Company is required indicating consent to be bound as surety and grantor for performance required under the Contract Documents.

**CONTRACTOR REGISTRATION:** Bidders are required to be registered by the New Jersey Department of Labor at the time bids will be received by the owner pursuant to the Public Works Contractor Registration Act (P.L. 2003, c.91, N.J.S.A. 34:11-56.51).

**STATUTORY REQUIREMENTS:** Bidders are required to comply with applicable statutory requirements set forth in the Contract Documents including the requirements of P.L. 1975, c. 127(NJAC 17:27) (Affirmative Action) and P.L. 1963, c. 150 (Prevailing Wage) and Americans with Disabilities Act of 1990 (42 U.S.C. 12101, et. Seq.).
