# REGULAR MEETING MAYOR AND COUNCIL MARCH 23, 2015

# **Opening Items**

Mayor Chegwidden called the Meeting to Order.

Mayor Chegwidden read the Open Public Meeting Statement.

#### Roll Call

Mayor Chegwidden requested Roll Call:

# Flag Salute

Mayor Chegwidden led those in attendance with the salute to the American Flag.

#### Open to the Public

In accordance with Local Ordinance O-18-03, "Persons making public comment at the first public portion shall be limited to five (5) minutes. During the second public portion, the Mayor or Council President shall have the discretion to terminate any repetitive, irrelevant or excessive public comment in the interest of permitting all members of the public time to speak on any governmental issue and completing the public business within a reasonable period of time".

Mayor Chegwidden opened the meeting to the public.

Mike Obremski, JCP&L: He came to advise the Council that JCP&L has announced that they will be spending \$267 million to enhance the electrical system. Included in that plan is an update to the West Wharton Subsystem that will stabilize the voltage in all of North Jersey on a transmission level. They are also installing some new technology that will benefit customers in town. They are also planning on spending \$24 million on tree trimming. More discussion with Mr. Obremski continued.

Mr. Rheinhardt advised that the next step after signing these agreements is doing the bidding. More discussion about this followed.
