Council Reports

Council President Binkoski: Stated that the Fire Department had won 6 trophies at the parade they recently attended. The American Legion Color Guard had also received one trophy. Councilwoman Wickenheisser: Stated that Wharton Recreation ended on August 11th. The Football/Cheer pep rally will be on September 8th and opening day of Soccer will be on September 16th.

Mayor Chegwidden's Report: Stated he attended the Planning Board meeting. He stated there was a person there who was looking to add on to their home just so they could stay in Wharton. He stated that Costco is expanding and getting a bigger produce area in the store. He stated that the closing on the Green Ten property is finally complete and construction should start soon. He also stated that Canal Day is scheduled for August 19th and the Betty Poyer field is going to be dedicated at that event with a plaque. He thanked the Wharton Fire Department for their hard work. He also congratulated American Legion Post 91 for their trophy. He stated that the American Legion will be attending this year's 5K Camo Color Run with their Color Guard and inviting everyone back to the Post after the run.
