A lot has happened in 2017. Throughout the course of the year the Municipal Alliance has done a lot for Wharton and he thanks Ms. Ghebreal for that because we serve as a model for other Alliances. This year they were involved in a lot of events: Screenagers at the schools, the Alliance/FOP Carnival which earned over \$26,000 that goes back into the community, 5K Color Run with the military, various drug and alcohol awareness programs and speakers at the schools, adopting the STOPIT app that was set up at the school which works to prevent bullying and suicide among students, HalloWharton, which was just for Wharton residents this year, dances at the schools, Narcan class, and setting up visits from the Hope One Van through the Sheriff's Department.

Also done this year were many road improvements including: Sherwood Place, Potter Lane, Hance Street, Maple Terrace, Cornell Street, Eileen Court, Atlanta Place, W. Clarence Street, Huff Street, Mt. Pleasant Ave., and Terry Lane. Princeton Ave. which was done with a grant for \$245,000, East Central Ave. which was done with a grant for \$80,000, Oxford/Cambridge Roads which were done with a grant for \$80,000. West Central Ave. which was done with a grant of \$160,000.

We also completed the new water tank at the North end of town. It holds one million gallons of water. We also expanded our holiday decorations on Main Street. We have received a lot of compliments on them. We need to thank the Police Department for giving us the grant to purchase the new decorations. In our parks, we have purchased a new soccer field concession stand and it will be open this spring season.

We continued to increase communication. Early in 2017, we created a Borough Twitter account and the Mayor's monthly newsletter. Both have received positive feedback from residents. We have installed a new surveillance system at the recycling depot. People are still dumping in there, but now they are being fined for that illegal dumping. We purchased a new garbage truck, a new mason truck. We have a program to make sure that we keep our vehicles up to date.

On the horizon for 2018, we just received a trails grant for Irondale Mountain for \$71,000 to mark all of the trails up there. We're continuing work on revitalizing Main Street. The former green tent property will be breaking ground in the spring and there is other development that will be happening on Main Street. The Main Street extension is in the County's budget for 2018. He's been waiting a long time for that to come to fruition and it looks like it will finally happen this year. We're hoping that Wharton Woods also finishes their project this year.

Also, with the sale of the senior building we will be getting in 1.3 million. With some of that money we will be partnering with Habitat for Humanity for a program that helps seniors with projects that allow them to age in place in their homes. It's not COAH money, which is a big difference, but it can be used to help seniors with housing.

The CFO advised that we continue to be in great financial shape. We remain the second lowest municipal tax per capita for all of Morris County and the fourth lowest tax per capita for total taxes in Morris County. We're very proud of that. Councilman Corbett advised that we are also the lowest in combined water and sewer bills as well.

He would also like to congratulate Councilman Binkoski and Councilwoman Hayes. The entire Council are good workers. It is great that the Mayor and Council have always worked as a team here. He was glad to hear what Councilwoman Veres said in her report, because we always try to welcome everyone as family since we are all working for Wharton. It is a great little town and he hopes that we continue in the same direction this year coming up.
