REGULAR MEETING MAYOR AND COUNCIL MARCH 22, 2021

Mayor Chegwidden called the Meeting to Order

Mayor Chegwidden read the Open Public Meeting Statement

Mayor Chegwidden requested Roll Call:

Council President Wickenheisser- Present
Council Binkoski- Present
Councilwoman Hayes- Present
Councilman Norton- Present
Councilwoman Vasquez- Present
Councilman Yeager- Present

Also in attendance were Administrator Jon Rheinhardt, Borough Clerk Gabrielle Evangelista and Attorney Roman Hirniak.

Flag Salute

Mayor Chegwidden led those in attendance with the salute to the American Flag.

Presentations

- Public hearing on municipal parking lot project: Mr. Rheinhardt went over the plans to re-do the parking lots around Town Hall, the Police Station, and the Library. Residents and nearby business owners- Fran Schurgot, Brandon and Tom Rodkewitz, and Mark Nowak had some questions and suggestions about the current plans. Ms. Shurgot was concerned about light from the car's headlights shining into her home as well as having a barrier to avoid cars accidentally coming onto her property. Mr. Brandon Rodkewitz asked about the change to the intersection and wanted to make sure that there was enough room for businesses to receive deliveries. Mr. Tom Rodkewitz asked about on street parking. Mr. Nowak brought up an issue that he is going to have with the ability for a truck with a crane to be able to pull up to his building as necessary. We will bring the concerns and suggestions to the Engineer of the project to see what solutions he can come up with. There was also discussion about electric vehicle charging stations, which are not going to be put in at this time, and permitted parking spots. Everyone thanked the residents and business owners for coming.
- Legal update on recently adopted cannabis legislation: Mr. Hirniak, along with Chief Young, went over the attached presentation on the recently adopted cannabis legislation. After a short discussion, Councilman Yeager

made a motion to have the proper ordinances drafted for the Borough to opt out of licensing all 6 classes of establishments, which was seconded by Council President Wickenheisser.

There was also discussion about the need to update the Borough's ordinances for use in public places. Councilman Yeager made a motion to have the proper ordinances updated to prohibit use in public places, which was seconded by Council President Wickenheisser. This motion was approved via voice vote. Chief Young will work with Council President Wickenheisser and Councilwoman Vasquez on these updates and will bring them back to the Mayor and Council for consideration.

During the second public portion repetitive, irrelevant or excessive public comment in the interest of permitting all members of the public time to speak on any governmental issue and completing the public business within a reasonable period of time".
