# REGULAR MEETING MAYOR AND COUNCIL APRIL 19, 2021

Mayor Chegwidden called the Meeting to Order

Mayor Chegwidden read the Open Public Meeting Statement

Mayor Chegwidden requested Roll Call:

### Flag Salute

Mayor Chegwidden led those in attendance with the salute to the American Flag.

### Open to the Public

In accordance with Local Ordinance O-18-03, "Persons making public comment at the first public portion shall be limited to five (5) minutes. During the second public portion repetitive, irrelevant or excessive public comment in the interest of permitting all members of the public time to speak on any governmental issue and completing the public business within a reasonable period of time".

Mayor Chegwidden opened the meeting to the public.

No one wishing to be heard, Mayor Chegwidden closed the meeting to the public.

#### 2021 Budget

Councilwoman Hayes advised that the 2021 Budget \$10,069,540 which is \$207,503 lower than our 2020 budget. Total taxes for both the town and the library are \$4,178,146 which is an overall decrease of \$45,811. Library taxes are increasing \$6,099.30 while the town taxes are decreasing \$51,910.60. The impact on a personal property is estimated at \$2.74 increase for the library and \$14.62 decrease for the municipal tax. Contained in this budget is an aggressive capital plan that includes paving projects for Lafayette St. which we have a grant for \$231,700, municipal and library parking lot improvements, which we have a grant for \$80,000, continuation

of trail systems through Irondale Mt., which we have a grant for \$154, 398, a new fire truck, library furniture, and various other equipment.

### **Resolution**

Councilman Yeager introduced R-70-21 "Resolution to Read the Budgets by Title Only."

A motion was made by Councilman Yeager and was seconded by Councilwoman Hayes to adopt Resolution R-70-21.

### **2021 Municipal Budget**

Councilwoman Hayes presented Resolution R-59-21, The 2021 Municipal Budget for final adoption.

# **Council Reports**

<u>Council President Wickenheisser:</u> She expressed her condolences to the Fernandez and O'Malley families, which was echoed by everyone present.

<u>Councilman Binkoski:</u> The DPW is working a few projects and things are starting to look good out there.

<u>Councilwoman Hayes:</u> Thank you everyone for their kindness for the last few months when she was dealing with her mother's illness. Everyone stepped in as needed and she really appreciates how well this group works together. Thank you to the Mr. Rheinhardt and the Finance Committee on their work on the budget. They just finished negotiations with the DPW and are currently working with the FOP.

Councilman Norton: We received a recreation facility application for a company that is looking to use Robert Street one day for a demonstration for Picatinnny. He suggests waiving the fee since it is for the military. He made a motion to do so and approve the application, which was seconded by Councilman Yeager. This motion was approved via voice vote. He attended the opening ceremonies for soccer, which was very well attended and the field conditions were amazing. The Job Fair is scheduled for 4/21, but weather sounds like it may still be an issue so it may be on the rain date of 4/22. The clean-up day is scheduled for 6/5, he spoke with Ms. Craven and her suggestion was to give the volunteers their assignments in advance and then a bagged lunch will be brought to them there. After some discussion the Mayor and Council would like it to be like it usually is with lunch provided at the DPW afterwards. It is a large outdoor area so people can effectively socially distance as necessary. The shredding and garage sales with no fee for the permit will also take place on that day. They are looking at a grant for recreation some options they are looking at are for Robert Street to improve the area around the swings, the clubhouse, putting in a walking path, and changing the angle of the football field.

Mr. Rheinhardt advised that there are actually 2 grants, one is small, but we will apply for it. They are looking at using one of the grants to put in some new benches as well.

<u>Councilwoman Vasquez:</u> The Library opened last week. Thank you to the DPW for their work to get things ready. Assemblywoman Dunn is going to have a satellite office program at the Library so that residents are able to come in if they need anything from the Assemblywoman's office.

Councilman Yeager: He met with the Fire Department and they had 12 calls in March. He met with Chief Young who is working on signage for Chegwidden Way and is working with Mr. Hirniak about the ordinance for the parks.

### Mayor Chegwidden's Report

He attended opening day of soccer and it was very nice to see everyone there. The fields are beautiful. We've been having some problems with the development at 10 Main Street, because Verizon has been holding things up with the placement of the poles. He called a representative who he never heard from again so he spoke with Senator Bucco who placed a call to them as well. They finally came today and did half of what they were supposed to. They had no problem taking the money from the developer and then not moving on the project. It's sad because we have no other options. He was on a call today with the New Jersey Conference of Mayors who are planning a webinar for Mayors to meet with the utility companies. They are also planning on talking with the Department of Education from Minnesota who put a plan in place several years ago that reduced their property tax. They are going to do a presentation for the NJCM about how they did it. Each State does different things and if it works for them, why can't it work for us.

Mr. Rheinhardt advised that the new County Road will be dedicated at a ceremony on April 29<sup>th</sup> at 2:30 p.m. and the road will be opened for use following the ceremony.
