## **Ordinance**

Council President Wickenheisser introduced O-12-21, "An Ordinance by the Borough of Wharton, County of Morris, New Jersey, to Amend Chapter 165, "Land Use and Development," Section 165-90, "General Provisions," Subsection 165-90A, "Prohibited Uses" of the Borough Municipal Code, to Prohibit the Operation of Any Class of Cannabis Businesses within the Borough's Geographical Boundaries," on first reading, by title only.

## **Council Reports**

Council President Wickenheisser: No Report

Councilman Binkoski: Stated that he met with the negotiations committee for the Police Department union contract. He stated he spoke with Administrator Rheinhardt regarding best practices for the residents to contact Department of Public Works with their issues. He thanked Chief Young for all his work on Chegwidden Way.

Councilwoman Hayes: No Report

Councilman Norton: Stated that a grant was submitted to the Department of Community Affairs for recreation improvements at Robert Street Park. He asked the Council to use money from the Babe Ruth budget, which has not been used in three years, to cover the cost of a tent for summer camp.

A motion was made by Councilman Norton and Seconded by Councilman Binkoski. All in favor: 6

Councilwoman Vasquez: Stated the Library added one day a week that they are open later. She stated the Library extended their hours for the month of June and are now open on Saturdays.

Councilman Yeager: No Report

Mayor Chegwidden's Report: Stated that he has been out campaigning and residents are telling him how happy they are with the new Chegwidden Way. It is helping with traffic flow. He thanked the County for following through and finishing the road. Chief Young mentioned that Chegwidden way is now on GPS direction apps. Mayor Chegwidden stated that there are garbage issues at Sterling Street Park. He went to the park and spoke with the children who were playing there. He said he told the children that if they do not keep the basketball courts and park clean, he will take down the basketball nets. He stated the children were respectful and cleaned up the garbage. He stated that the 10 Main Street project is moving quickly. He stated that the Memorial Day Parade and Services would be on Monday, May 31st.

• Chief Young stated that there are complaints from residents around the school area of speeding and failure to stop at stop signs. The Police Department is looking into the issues on Lafayette, E. Central, Baker, Sterling and Columbia streets.
