REGULAR MEETING MAYOR AND COUNCIL JUNE 27, 2022

Mayor Chegwidden called the Meeting to Order

Mayor Chegwidden read the Open Public Meeting Statement

Presentation

On behalf of the Wharton Police, Chief Young presented former Crossing Guards Joyce Hon and Martha Hoffman with plaques in honor of their retirement. He thanked them for their service to the Borough and wished them the best in their retirement, which was echoed by everyone in attendance.

Open to the Public

Mayor Chegwidden opened the meeting to the public.

No one wishing to be heard, Mayor Chegwidden closed the meeting to the public.

Resolution

Councilman Yeager introduced R-86-22, "Resolution Authorizing the Appointment of a Police Sergeant."

A motion was made by Councilman Yeager and was seconded by Councilwoman Hayes to adopt R-86-22.

Resolution

Council President Vasquez to introduce R-88-22, "Resolution Authorizing the Appointment of a Class II Police Officer."

A motion was made by Council President Vasquez and was seconded by Councilwoman Hayes to adopt R-88-22.

At this time, two Police Officers, Ryan Smith and Jack Rand, who were previously appointed, but not ceremonially sworn in, were sworn in. Congratulations were offered by all in attendance.

Discussion

- Request for road closure of Cross St. for a block party on 7/16. We have previously approved this request with no issues. The Council approved this request via voice vote.
- Referring a potential ordinance relating to chickens to the Board of Health: Mayor Chegwidden advised that he asked the Housing and Zoning Officer and the Health Officer to attend the meeting because a potential new ordinance would be passed by the Board of Health, but concerns the Housing and Zoning Officer as well. Housing Zoning Officer, Mr. Lewthwaite advised that following complaints and other issues with backyard chickens in town he reviewed multiple other towns ordinances for guidance and put together a draft for the Board of Health

to consider as a starting point. It is not too restrictive and allows most people who would want to have backyard chickens to do so, but with some regulations. There are sanitary concerns as well as safety and traffic concerns with this issue. Health Officer, Trevor Wiegle advised that some of the health concerns about this include the type of coop, food for the chickens, waste management, rodent control, and that chickens are prey for other animals. He advises careful wording of the ordinance. A discussion on this item followed including multiple members of the Council. Items that were discussed included- other towns ordinances to review, number of existing homes with chickens in town, roosters, and yard size in relation to coop size. Mr. Lewthwaite noted that this is not to stop people from having chickens, but to regulate it so it's safe and healthy for everyone.

Mayor Chegwidden opened the meeting to the public relating to this topic.

Ana Jones, 124 Old Irondale Rd.: Ms. Jones has chickens on her property. Prior to getting them, she educated herself on proper ownership and takes good care of her coop. Her yard is cleaned well and she hasn't seen any rodents. She likes having a food source and teaching her granddaughter about where food comes from.

<u>Scott Hutchins, DPW Director</u>: Mr. Hutchins clarified that the intent is not to not allow people to have chickens, but to make it so that it works for everyone. Responsible owners are not the problem, but there are always people who don't follow the rules. We may want to consider including an educational component for those looking to register.

<u>Russel Sieb, NJ Pest Control</u>: Mr. Sieb has a lot of experience in this area and is willing to consult if necessary. Any regulations have to be a well written program and you need responsible owners.

This matter will now be referred to the Board of Health.
