

NOTICE TO BIDDERS BOROUGH OF WHARTON - SCADA SYSTEM IMPROVEMENTS

NOTICE TO BIDDERS is hereby given that sealed bids are invited and will be received as set forth herein.

OWNER: Borough of Wharton, 10 Robert Street, Wharton, NJ 07885, Morris County, New Jersey

DESCRIPTION: The work consists of the implementation of a fully functional SCADA system for a public water supplier as detailed in the project manual and contract drawings. This includes, but is not limited to, the installation of new PLC panels, communication hardware, conduit and wiring, instrumentation, motors, and VFDs. The project also includes programming of the cloud-based SCADA platform to achieve the desired process controls for the water supplier.

OBTAINING CONTRACT DOCUMENTS: Contract Documents may be obtained, electronically only, at no cost, by contacting the Engineer at cborinski@chacompanies.com or 973-805-6082. Contractors that obtain Contract Documents from a source other than the Issuing Office must notify the Issuing Office in order to be placed on the official Plan Holders List, receive Addenda and other Bid correspondence. Bids received from Contractors other than those on the official Plan Holders list will not be accepted.

BID SUBMISSION PROCEDURES: Bids must be submitted on the Bid Forms contained in the Contract Documents and must be enclosed in a sealed envelope plainly marked on the outside with the name of the project and the name and address of the bidder. The bid must be delivered to the owner prior to bid opening at the above address. Bids will not be accepted after August 28, 2020 at 10:30 A.M. Please note that all bids must be dropped off to the Borough Municipal Building at the drop box located at the West Central Avenue entrance to the building. Please place all bids in the box no later than 10:30 am. The Clerk will retrieve all bids at 10:30 am and close the bid.

PUBLIC BID OPENING AND READING: Bids will be opened and read aloud, live via an online link after the bid is closed on August 28, 2020 at 10:30 A.M. The online link will be provided to Plan Holders in advance of the opening.

BID SECURITY: Bid Security is required in an amount of not less than ten percent (10%) of the total amount of the Bid, but not in excess of Twenty-thousand Dollars (\$20,000.00) as set forth in N.J.S.A. 40A:11-21.

CONSENT OF SURETY: Certificate from a Surety Company is required indicating consent to be bound as surety and grantor for performance required under the Contract Documents.

CONTRACTOR REGISTRATION: Bidders are required to be registered by the New Jersey Department of Labor at the time bids will be received by the owner pursuant to the Public Works Contractor Registration Act (P.L. 2003, c.91, N.J.S.A. 34:11-56.51).

STATUTORY REQUIREMENTS: Bidders are required to comply with applicable statutory requirements set forth in the Contract Documents including the requirements of P.L. 1975, c. 127(NJAC 17:27) (Affirmative Action) and P.L. 1963, c. 150 (Prevailing Wage) and Americans with Disabilities Act of 1990 (42 U.S.C. 12101, et. Seq.).

REJECTION OF BIDS: The Borough of Wharton reserves the right to reject any or all bids, or to waive any bid defect where such defect is not detrimental to the best interest of the Borough of Wharton and fairness of the bidding process. The right is also reserved to increase or decrease the quantities specified in the manner designated in the Contract Documents.
