MORRIS COUNTY COMMUNITY DEVELOPMENT PROGRAM REQUIREMENTS:

Funding for this project is provided by the United States Department of Housing and Urban Development to the County of Morris. Therefore, the Federal Labor Standards Provisions and Davis Bacon wage rates and reporting will apply.
