### **Opening Items**

Mayor Chegwidden called the Meeting to Order.

### **Discussion**

- 1. Ordinance updating time off section of personnel ordinance: Ms. Evangelista advised that we recently switched to a new time off request system through our payroll system which brought to light some things in the vacation time section of the personnel ordinance that no longer reflect our current practice. This ordinance makes the appropriate updates. Council President Binkoski suggested one additional change and asked a question about why one week is required to be taken at once. Mr. Rheinhardt advised that is an internal control, as you can see if there are issues when a person is out of the office for a full week. Everyone agreed that the ordinance could be on the next agenda for first reading.
- 2. Ordinance updating due dates for water bills: Mr. Rheinhardt advised that the current ordinance had no set times when water bills were to be due on. We feel that it would be easier for residents to plan ahead if they know that they will always have a water bill due on a specific date. He noted that the proposed dates are opposite of those when sewer and tax are due in order to lessen the financial burden all at once. After a short discussion, everyone agreed that the ordinance could be on the next agenda for first reading.
