**Opening Items**

Mayor Chegwidden called the Meeting to Order.

### Council Reports

**Council President Binkoski:** The Commander at the American Legion is selling shot glasses as a fundraiser. Everyone is welcome to stop by.

**Councilman Corbett:** He attended Hallowharton and would like to congratulate everyone involved in running it because it was well run and well executed. The American Legion fundraiser is for their 90<sup>th</sup> anniversary which is next year.

**Councilwoman Hayes:** Hallowharton was fantastic and she would like to thank everyone involved in running it especially the young volunteers.

**Councilwoman Veres:** She attended the Library Board Meeting on 10/17 and they have a program on 11/14 from 3-6:30 p.m. with a speaker on the new adoption reform act as a part of November being Adoption Awareness Month.

**Councilwoman Wickenheisser:** She also attended Hallowharton. It was very well run this year and she thanks everyone involved.

**Councilman Yeager:** He attended the Planning Board meeting where a subdivision was approved.

### Mayor Chegwidde's Report

He also attended the Planning Board meeting. He would like to thank Ms. Ghebreal and all of the volunteers who helped out at Hallowharton. The numbers were much more manageable this year, with it being only for Wharton residents. He also thanks the Police for handing out hot dogs to all of the attendees.

He had a discussion with Mr. Rheinhardt about what to apply for the CDBG this year, they are proposing applying for re-doing the bathrooms in the basement of the library. They are in bad shape.

He would like to bring to the Council's attention that for County Tax per person Wharton we are 4<sup>th</sup> lowest in the County, for County Open Space we are 4<sup>th</sup> lowest in the County, for District Schools we are 5<sup>th</sup> lowest in the County, for Regional Schools we are 2<sup>nd</sup> lowest in the County, and for Municipal Tax per person we are 2<sup>nd</sup> lowest in the County. The only town who is lower for Municipal Tax is Victory Gardens, which has no school, Police Department, or garbage collection, which makes the comparison a bit apples to oranges. For Library Tax we are 2<sup>nd</sup> lowest in the County and for total tax per person we're 4<sup>th</sup> lowest in the County. Councilman Corbett noted that in a lot of other towns you are also paying separately for garbage collection as well.

### Open to the Public

Mayor Chegwidde opened the meeting to the public.

**Ed Nunn, Chief Wharton Fire Department:** On October 17<sup>th</sup> 5 Members of the Fire Department- Kevin Finnegan, Joseph Harder, Robert O'Malley, William Shupe, and Frank Wheatley Sr. were honored by the County Clerk for being Veterans and

**Fire Fighters. It was a very nice event. Since October is Fire Prevention Month, he would like to remind everyone to check their smoke detectors and carbon monoxide alarms. The batteries need to regularly be replaced and the entire detector needs to be replaced every 10 years. They've been having a lot of calls relating to this recently. Mayor Chegwidden advised that he will put a note in his next newsletter about this. Chief Nunn continued that, the safe trick or treat at the Firehouse is scheduled for tomorrow evening.**

**No one else wishing to be heard, Mayor Chegwidden closed the meeting to the public.**
