Mayor Chegwidden Called the Meeting to Order

Mayor Chegwidden read the Open Public Meeting Statement

**Flag Salute**

Mayor Chegwidden led those in attendance with the salute to the American Flag.

Mayor Chegwidden advised that prior to opening to the public, he would like to thank some people. First, the President and Vice President for helping to get us the equipment that we need. Thank you to the State, the Governor, and the County for setting up testing systems. He also thanks Councilwoman Wickenheisser who has been volunteering at one of the testing sites. Thank you to all of the doctors and nurses who have been on the front lines taking on a big responsibility every day. Thank you to our first responders who are out every day. Thank you to our health department and our nurse for everything they do, he is very proud of them. Lastly, he wants to thank the residents for doing the right thing and staying home. The curve is starting to come down. As of today, we have 110 total cases in Wharton, 27 recoveries, and 4 deaths. He would like to take a moment of silence for those residents who have passed.

**Morris County Freeholder, Stephen Shaw:** Freeholder Shaw advised that himself and the other Freeholders have been able to attend more Council meetings with them being held virtually. He wants to thank the Mayor and Council for their work during this trying time. He also echoes all of the thanks from Mayor Chegwidden to the first responders and hospital workers. The County is operating and are carrying on providing essential services. Certain departments such as the County Administrator, Health and Human Services, and the Sheriff's Department have been putting in a lot of work and are doing a great job, they are willing to assist with whatever has been asked of them. The County testing sites are operating well and have been able to set aside some appointments for Sussex County as well. The

County is here to help the town with whatever they can. He offers his condolences to the families of those we have lost.

Mayor Chegwidden thanked Freeholder Shaw and thanked the County for everything that they are doing.

**Former Councilman, Glenn Corbett:** Councilman Corbett asked since there was an increase between last Friday and today if the town is aware of any area of town that has a cluster of cases of COVID-19. Mayor Chegwidden advised that we are not made aware of locations, and have not heard of any clusters. Councilman Corbett advised that it will be interesting to see going forward if there were any clusters, what the cause of them may be, and if there's anything the town can do to alleviate them.
