**Council Reports**

**Council President Binkoski: Stated he had attended the Department of Public Works negotiations meeting. He attended the Library Committee meeting which was very productive.**

**Councilwoman Hayes: Stated that she attended the Department of Public Works negotiations meeting. She stated how nice the town looks with the holiday decorations. She congratulated Gabby and her family on their new baby.**

**Councilman Norton: Stated that the Annual Tree Lighting Ceremony will be held on Sunday, December 13<sup>th</sup> at 6:00 pm in Memorial Park.**

**Councilwoman Vasquez: Stated that she attended the Library Committee meeting. There were 61 people who responded to the library surveys. She stated she tried to stop into the Annual Free Rabies Vaccine Clinic but there was no parking. Councilman Norton stated that he did attend the clinic and there were too many out-of-town people at the event that caused much more traffic and people attending. Mayor Chegwiddden stated that we will try and hold the clinic on a Saturday next year.**

**Councilwoman Wickenheisser: Stated that the town looked great with the holiday decorations and thanked the DPW for putting them up. She wished everyone a Merry Christmas and a happy holiday.**

**Councilman Yeager:** Stated he had met with Chief Young and discussed some new ideas for signage outside the Police Department to make it easier for the public.

**Mayor Chegwidden's Report:** *Stated that he and Jon Rheinhardt, Administrator, received information from Morris County regarding free COVID tests for residents. Morris County residents will be offered 2 free tests per month. Residents will need to show ID to go to be tested or receive at home tests. He stated he walked the new road and adjoining property and there is a lot of overgrown bushes and trees that need to be removed. He stated that we need to have the rabies clinic next year on a Saturday again and for a longer period of time to accommodate everyone attending. He stated that he and Councilwoman Vasquez attended the NJLM dinner in Long Hill Twp. He attended the Veteran's Day Eve ceremony at the American Legion and the Eagle Scout project presentations. The Eagle Scout project was great and when we resume in person meeting's he will invite Eagle Scout Gonazalez to attend a Mayor & Council meeting to be presented with a proclamation. He stated that he was sworn in as Vice President of the New Jersey League of Municipalities and it was an honor to hold that station. He wished everyone a Merry Christmas and Happy Holiday.*
