- 1. Obtain a "Youth Sports Questionnaire Form" and the "Wharton Borough Volunteer Waiver and Consent Form" from the Wharton Police Department, Wharton Town Hall, or through a youth sports team coordinator.
- 2. Schedule an appointment at IdentoGo to be fingerprinted.
 - Login to https://uenroll.identogo.com/
 - Enter service code: 2F1J3Y
 - Click on "Schedule or Manage Appointment" and follow the prompts
 - Enter P19002 under the Contributor Case Number
- 3. Go to IdentoGo at your scheduled appointment time to be fingerprinted.
- 4. Complete the "Youth Sports Questionnaire Form" and the "Wharton Borough Volunteer Waiver and Consent Form" in its entirety. Ensure that you have the "Wharton Borough Volunteer Waiver and Consent Form" notarized.
- 5. After you are fingerprinted submit the "Youth Sports Questionnaire Form" and the "Wharton Borough Volunteer Waiver and Consent Form" directly to the police department.

Your fingerprint response will be sent to the police department via mail. Once all documents and your fingerprint response are received, detectives from the Wharton Police Department will complete a background investigation.
